Tony Yeung, accountant at a skincare and health products company, tells us how AAT graduate Daisy Tai helps him with her efficient handling of the company's accounts.

Tell us about the company.

Health Quotient Consultants Company Limited (HQCC) is a skincare and health care products trading company, and was founded in 1998. We provide safe and evidence-based healthcare products to our target customers, who are mainly office ladies with high purchasing power. Currently, we sell a number of major brands of skincare and health supplements in our 14 outlets in mainland China, Hong Kong and Macau. Our products can also be found in other chain retailers, such as Mannings. We also do wholesale business, and the turnover split between retailing and wholesaling is seven to three.

What are your main roles in the company?

I have been working at HQCC for ten years. I am now the accountant in charge of the company. I have two subordinates and Daisy is one of them. I lead the team and prepare different financial reports and forecasts which I present to the management on a timely basis. As the company is part of the fast-moving consumer goods industry, we have to keep a low cost for our operations and work in a highly efficient manner so as to remain competitive. Order taking and delivery processes have to work seamlessly with the support from the warehouse and backend-accounting system. Therefore, it is crucial for us to have effective accounting policies and procedures to ensure efficient and accurate internal controls.

How do you know about the HKIAAT? What are your views on the HKIAAT and the AAT qualification?

I am in fact an AAT student and therefore I know the benefits of the AAT qualification very well. This qualification is widely recognized by employers in Hong Kong. The examination syllabus is broad and covers a diversity of business disciplines which are required by today's accounting personnel.
