



Guangzhou Study Tour 2009

To provide members and students a better insight into the accounting regime in the mainland, we are organizing a three-day Guangzhou study tour during Christmas holidays. Details are as follows:

- Date: 24 - 26 December (Thursday to Saturday)
- Max. no. of participants: 40 HKIAAT registered members/students
- Accommodation: A 4-star hotel in Guangzhou
- Activities (tentative):
1. Academic exchange with accounting students of Guangzhou University Town (Guangdong University of Foreign Studies) 廣州大學城 (廣東外語外貿大學)
 2. Visit to the Nansha Economic & Technology Development Zone 南沙開發區, Nansha Taxation Bureau 南沙區國稅局
 3. Visit to a CPA firm 拜訪會計師事務所
 4. Visit to GAC Toyota Motor Co., Ltd. 廣汽豐田汽車有限公司 & Yangcheng Evening Paper Printing House (羊城晚報) 報社
 5. Sightseeing
- Fee: HK\$650 per head for HKIAAT members/students (including round-trip fare from HK to Guangzhou, transportation costs in Guangzhou, meals, accommodation, admission fees for scenic spots, insurance, etc. The balance is subsidized by the HKIAAT.)
- Closing date: **Friday, 4 December 2009**
