I. Completion of the Form

The application should be supported by relevant certificates and transcripts. They must be certified as true copies by any one of the following parties:

- (i) Member of any Professional Accountancy Bodies (e.g. HKICPA); or
- (ii) Legal Practitioner; or
- (iii) A Government District Officer (through statutory declaration); or
- (iv) HKIAAT (originals must be produced in person at our office for certification).

Only official documentations issued by appropriate educational institutes or examination bodies will be considered. Please do not send originals if you lodge your application by post.

II. Payment of Fees

The fee for each paper is same as the prevailing rate for exemption / examination fee as set out overleaf. Payment should be in the form of crossed cheque or cashier order made payable to "Hong Kong Institute of Accredited Accounting Technicians Limited". No cash nor post-dated cheques will be accepted.
